With a sense of the First Nations country upon which Good Counsel Primary is situated, where learning and ceremony have taken place over many thousands of years, we acknowledge the Mamu People and pay our respects to all Elders – past, present and emerging.

Dear Parents/Carers.

Our Attendance Bike Competition has created much talk and excitement in the Blue Area over the past week.



One of our School Improvement goals over the last three years has been to increase the attendance rate of all students. We need parental/carer assistance for this strategy to work and our goal is 90% students attending 90% of the time with less than 5% unexplained absences.

Attendance does matter!

A bright future for your child starts with good school attendance every day, all day. Good attendance doesn't guarantee positive outcomes for students, however, positive outcomes are unlikely to occur without good attendance.

Aim to get your child to school early. Having your child at school early allows them to socialise before school, prepare for their day and be ready for class. We also give students an opportunity on a Tuesday to Thursday to receive extra assistance with Homework Club.

- Just a little bit late doesn't seem much but - 20 minutes late equals 1.5 hours per week; 2.5 weeks per year means 1 whole year of 13 years of schooling.
- One or two days a week doesn't seem like much but - If your child misses 1 day a week that equals 40 days per year or (8 weeks) and nearly 2.5 years over 13 years of schooling.

Obviously, if your child is sick it is encouraged that they remain home, or if they have appointments during the day, this is unavoidable. Please contact the school Office or lodge their absence on the Parent Portal.

If you are having attendance issues with your child, contact your class teacher, Carmel our School Counsellor or myself so we can work together to get your child to school every day.

Collection Notice for parents/guardians

2023 Student Residential Address and Other Information

The Australian Government Department of Education (the department) would like to notify you that we have requested for your child's school to provide residential address and other information.

Under the *Australian Education Regulation 2013,* the school is required to provide the department with the following information about each student at the school:

- Names and residential addresses of student's parent(s) and/or guardian(s)
- Student residential address (excluding student names)
- Whether the student is a primary or secondary student (education level)
- Whether the student is boarding or a day student (boarding status).

The school collects the above information by generating a **unique and unidentifiable** – student reference number (SRN) for each student record. The school only uses the SRN for this collection. **It is not allowed to be used for any other purpose**. The number only indicates to the department that each record provided is for one student.

Purpose of the collection

The Student Residential Address and Other Information Collection (the Collection) informs Australian Government school education policy and helps ensure funding for non-government schools is based on need.

The information collected will be used to inform school funding calculations. It is combined with Australian Bureau of Statistics (ABS) data to calculate a non-government school community's capacity to contribute to schooling costs.

From 2020, the department introduced a new measure of capacity to contribute: the Direct Measure of Income (DMI). The DMI is based on the median income of non-government school students' parents or guardians using the Collection data. Use and disclosure of personal information

Your personal information is protected by law under the *Privacy Act 1988* (Cth) (Privacy Act). Personal information is information or an opinion about an identifiable individual. Personal information includes an individual's name and contact details.

Any use or disclosure of your personal information must occur in accordance with Privacy Act and the *Australian Education Act 2013* and *Australian Education Regulation 2013*.

Your personal information provided to the department through the Collection may be:

- disclosed to the ABS for the purposes of capacity to contribute calculations and analysis as a part of the Multi-Agency Data Integration Project (MADIP). Find more information about MADIP on the ABS website MADIP page.
- disclosed to a contracted auditor where the department may from time to time, carry out an audit of
 a school's collection submission. The contracted auditor compares the school's submission with the
 school's student enrolment information. The contracted auditor will not use the information for any
 other purpose.

- disclosed to its service providers for the purposes of providing the department with information and communications technology support services.
- used or disclosed where it is otherwise required or authorised by law.

The department does not intend to disclose your personal information to any overseas recipients.

The department commissioned an independent privacy impact assessment (PIA). The PIA assesses the flows of information under the Collection, compliance with the Privacy Act and measures in place to safeguard the personal information being collected. What do you need to do?

You are not required to do anything. Your school is responsible for providing the department with the requested details; however, you can contact the school to update your family's details.
